Midget Division: (Born in 2000 and 2001)

Junior Division: (Born in 1998 and 1999)

Weights: 58, 62, 66, 70, 74, 78, 82, 86, 91, 98, 108, 120, 140, 166 MAX.

Intermediate Division: (Born in 1996 and 1997)

Weights: 75, 80, 85, 90, 95, 100, 105, 110, 115, 120, 128, 136, 150, 175, 220 MAX.

Advanced Division: (Born in 1994 and 1995)

Weights: 93, 100, 105, 110, 115, 120, 125, 130, 135, 140, 145, 152, 160, 171, 189, 215, 285 MAX.

Elite Division: (Born in 1992 and 1993)

Weights: 108, 117, 125, 130, 135, 140, 145, 152, 160, 171, 189, 215, 285 MAX.

Open Division: Born before 1992

Weights: 125, 135, 142, 150, 158, 167, 177, 190, 215, 295 MAX.

EVERYONE MUST COMPETE IN THEIR OWN AGE DIVISION EXCEPT those who exceed the MAXIMUM weight.

Please choose a weight you can make and maintain through Regional's & Eastern Nationals.

LENGTH OF BOUTS: Intermediate, Advanced, Elite, & Open: Three 1 1/2 minute periods; All others - three 1 minute periods; Overtime-Sudden Death: One- 1 minute period followed by a 30 second ride out period if necessary.

WRESTLING RULES: P.I.A.A. Modified rules; P.I.A.A. officials will be used. **EVERYONE** must have **PROOF OF AGE** if challenged; **INCLUDING** the **PERSON ISSUING** the challenge. **IMPORTANT:** Once you have qualified for the **REGIONAL TOURNAMENT** you **MAY NOT** enter another **DISTRICT TOURNAMENT**. **ANYONE WHO DOES WILL BE DISQUALIFIED FROM ADVANCING TO THE REGIONALS.** Any entrant who falsifies information on an application to enter a district or regional MAWA tournament will be subject to a one-year suspension from the program, effective immediately upon discovery.

AWARDS: Medals will be given to the top three finishers in each weight class. Ribbons will be awarded for 4th place.

UNIFORMS: One-piece singlets are **REQUIRED**. No T-shirts and no striped socks will be permitted.

DEADLINE FOR EARLY ENTRIES: March 14, 2010, Late Entry Fee will be **\$5.00**. **DO NOT** mail your application after March 14, 2010 – Entry forms must arrive at tournament director's home **NO LATER** than March 17th by **4pm** for seeding will begin at 5pm at another location.

There will be a \$10.00 advancement fee to be collected at the Regional Tournament. Fifth and sixth places are alternates.
